PASSPORT HEALTH

2000-2020 Provided Preventive Health & Vaccine Services to Chicagoland Area

- 14 travel medicine & vaccine clinics

- On-site corporate preventive health services including mass vaccination events

- Prior experience with emergency response to Anthrax, H1N1

- Within weeks of the pandemic, shifted all operations to COVID-19 Response efforts

2020-2021 Pandemic Response

- COVID-19 Screening Services for large essential employers – started in April of 2020

- COVID-19 Testing services - added in August 2020

 - Have provided over 50,000 on-site COVID-19 tests to mid and large corporate clients & school districts

 - Providing on-site COVID-19 testing at 31 schools in Chicagoland area

 - Experience with all testing formats (RT-PCR, RT-PCR Saliva, Molecular Testing, Rapid Antigen Testing, Antibody Testing)

- COVID-19 Vaccine Administration - supporting public health department efforts to administer vaccines to Phase 1B essential – added in February 2021

ROLE OF SHIELD ILLINOIS

SHIELD ILLINOIS – LAB PARTNER

On-site clinic planning

Lab Services

- Provide all lab supplies

- Provide and responsible for lab administration & reporting software (Point and Click)

- Perform RT-PCR testing on saliva samples

- Report all results of lab tests through the lab reporting software

- Ensure timely delivery of lab results

Medical oversight of testing orders and lab performance

ROLE OF PASSPORT HEALTH

PASSPORT HEALTH – ON-SITE TESTING ADMINISTRATION PARTNER

On-site clinic planning

- Location selection & site visits

- Help establish adoption of testing efforts

Communications

- Establish online testing portal

- Work with D113 on community testing communications

Scheduling

- Work with D113 to develop and establish a testing schedule to satisfy requirements of stakeholders

- Provide online scheduling portal

- Work with D113 on scheduling changes/challenges

On-site Testing

- Organize and staff on-site testing centers for both schools

- Manage patient flow, check-in/out process, administration of lab sample collection, transport samples to lab partner

Resulting

- Receive results from SHIELD ILLINOIS

- Respond to positive test results

 - Establish clinical protocol with D113 for management of positive results

 - Ensure notification of local health department of positive results

Medical Oversight of Test Administration

ON-SITE TESTING – UPDATE

DI 13 COVID Testing information site built

Testing location at DHS and HPHS set-up complete Thursday February 18

Testing to be performed twice weekly (Tuesday & Friday for students)

Teacher and Staff testing to begin Monday February 22

Student Testing consent collection, testing orientation and QR code distribution to occur the week of February 22

Student Testing to begin on Tuesday March 2

PPH Protocol for management of positive test results established

COVID-19 ON-SITE COLLECTION PROCESS

LINE UP

Students enter testing location (cafeteria) and line-up to await an open test sample spot

Most students arriving will go directly to an open test sample spot

They will ensure their personal QR code is ready to be scanned

GIVE SAMPLE

Once at an open tests sample spot, students will raise their hand to alert staff they are ready to give their sample

Staff will confirm their ID, write their DOB on their collection vial and give them a funnel, a vial and a vial cap

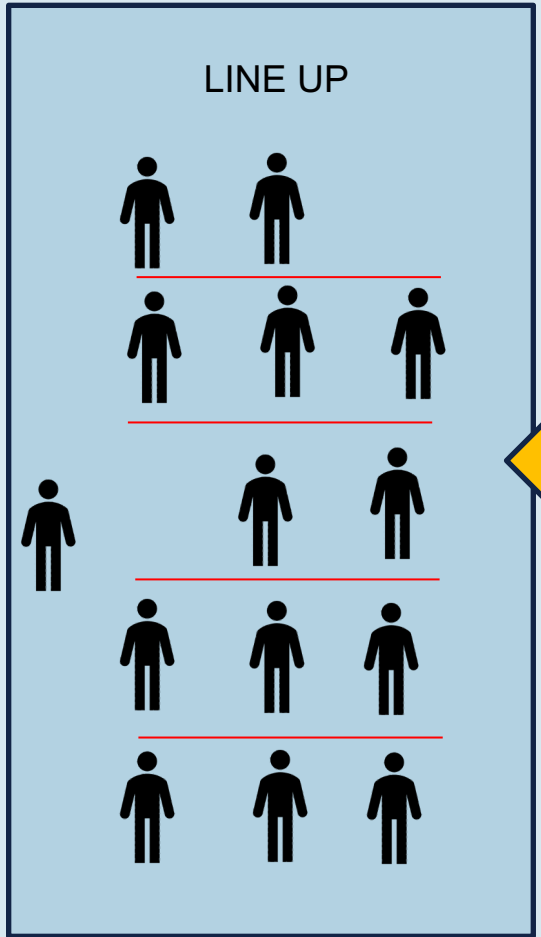
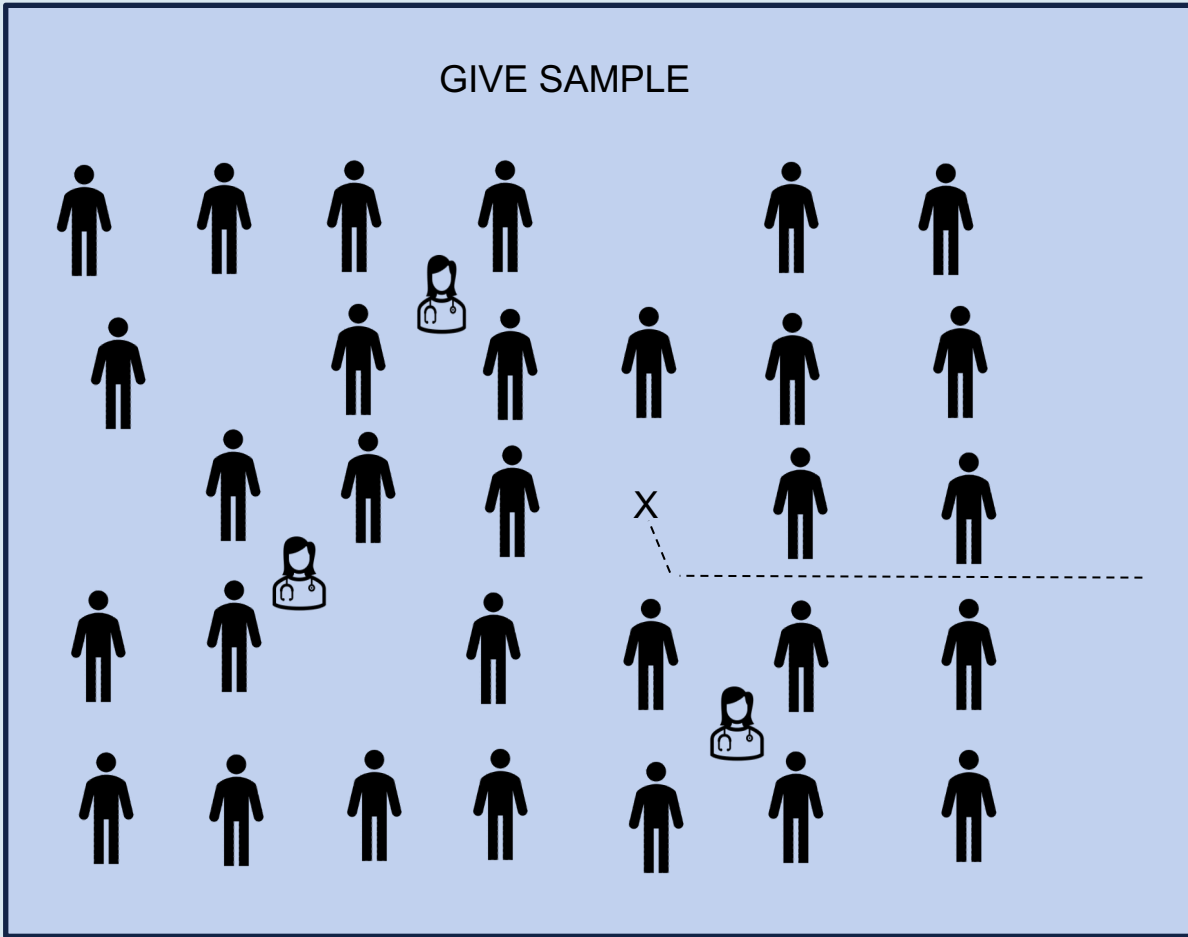
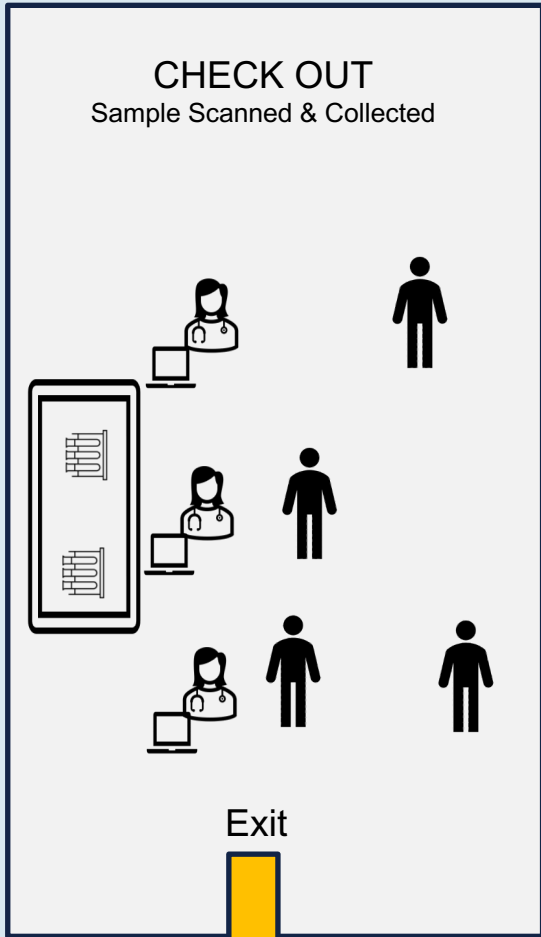
Students will fill the vial with 1ml of spit, cap the vial and then proceed to a check out station

CHECK OUT

Testing staff will scan participants personal QR code and confirm the correct DOB is on their sample vial

Testing staff will then scan the sample vial, associating that participant with that specific vial at the lab

Student will place the scanned vial in a sample rack and exit the testing location

POSITIVE COVID-19 RESPONSE PLAN

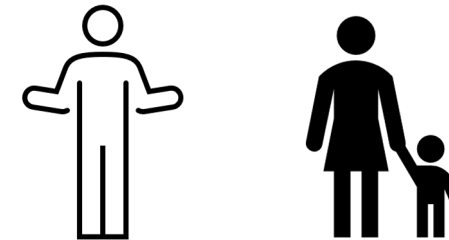

Passport Health Lead RN coordinates response with DII3 staff: Infected person and family notified. Infected person isolated & removed from facility.
