February 7, 2023 Committee of the Whole Meeting

Approval of Agenda

The Board voted to approve the February 7 agenda as presented.

Board Reports

President

Board President Ken Fishbain reported that a lot was accomplished when the Board and District Education Association Bargaining Teams met on February 3. The teams reached consensus on language for transfer (involuntary and voluntary), just cause, no-strike and non-discrimination, seniority, reduction in force and recall. In addition, the group discussed a work plan for the next several planned sessions. The next session is scheduled for February 15, 2023.

Members of the bargaining unit will continue to receive email updates about the collective bargaining process. These updates are available on the District's website.

Administration Information Reports

Superintendent

Superintendent Dr. Bruce Law began his report by announcing that the District 113 Art Show has opened and will run through February 12 at The Art Center in Highland Park. Dr. Law said the annual reception will be held Thursday, February 9. He said the art show is one of the best things about District 113 as it provides an opportunity to showcase in a beautiful exhibit space the amazing work of artists who happen to be students.

Dr. Law also reported that he was happy to announce the details for the February 21 event with Yale's Dr. Marc Brackett. The event will include the greater D113 community, including the other 440 Partners, sender elementary districts Bannockburn School District 106, Deerfield Public Schools 109, and North Shore School District 112. Dr. Brackett will be speaking with staff during the day and then in the evening will provide results from parent/guardian surveys to as well as present *The Power of Emotional Intelligence to Achieve Well-Being and Success in*
